



MEMORANDUM OF UNDERSTANDING

THIS AGREEMENT (hereinafter referred to as “**Agreement**”) is made on

INTERNATIONAL CULTURAL COMMUNICATION CENTER MALAYSIA (Company No: **1145493-U**) (hereinafter referred to as “**ICCCM**”), a company incorporated in Malaysia under the laws of Malaysia, and having its address at B-9-7, Megan Avenue II, No. 12, Jalan Yap Kwan Seng, 50450 Kuala Lumpur and shall include its lawful representatives and permitted assigns of the other party;

FOREIGN INSTITUTION (hereinafter referred to as The ICT University “**ICT-U**”), a Higher Education Institution from Cameroon / USA, and having its address at Avenue Dispensaire Messassi Zoatoupsi, Yaounde, Cameroon, P.O Box 526, / Baton Rouge, LA 70879, USA, P.O Box 86236, Baton Rouge and shall include its lawful representatives and permitted assigns of the other party; (**ICT-U** and **ICCCM** shall hereinafter to singularly as the “**Party**” and collectively as the “**Parties**”, as the case may be).

In order to promote human resource development through education, academic exchange and cooperation, The ICT University (ICT-U) and International Cultural Communication Center Malaysia (ICCCM) agree to sign the Memorandum of Understanding (MoU); details are following:

Article I: Purpose

The purpose of this MoU is to develop academic and educational cooperation on the basis of equality and reciprocity and to promote relations and mutual understanding between both institutions.

Article II: Scope of the Academic Exchange and Educational Cooperation

Parties hereby agree to cooperate in their mutual interest for a range of Higher Education and Research and Innovation activities, including - but not limited to - the following forms of cooperation:

- 1) Student exchange programmes at Undergraduate and Postgraduate levels on a unilateral and mutual basis for the purpose of education and/or research;
- 2) Faculty exchange programmes (short visits and short-term faculty exchange programmes included), on a unilateral and mutual basis for the purpose of lectureship, teaching and/or research; technical administrative and professional staff exchange programmes, on a unilateral and mutual basis, for the purpose of institutional capacity building and individual career development;
- 3) Joint organisation of higher education and training programmes (short-term higher education and training programmes included) on topics of mutual interest and invitation of each other's faculty and staff members to participate therein;
- 4) Joint organisation of seminars, conferences or workshops on topics of mutual interest and invitation of each other's faculty members to participate therein;
- 5) Joint application for external funding of higher education, training and research programmes and projects on topics of mutual interest at national and international levels and invitation of each other's faculty and administrative and technical staff members to participate therein;
- 6) Information exchange on higher education, training and research programmes;
- 7) Information exchange on teaching, learning material and other literature relevant to each other's educational, training and research programmes;



- 8) Other forms of bilateral international cooperation of mutual interest

Article III: Principles of Implementation

- 1) All specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds. Both parties should feasibly seek financial support from national and international organisations for the cooperative activities to be undertaken as stated under the terms of this MoU;
- 2) The ICCCM should facilitate and coordinate with partner universities to implement the MoU effectively;
- 3) Mutual visits of teachers/students and other collaboration plans can be discussed annually;
- 4) Scientific research projects, jointly-held academic meetings, teaching seminars and other agreed plans would be discussed separately;

Article IV: Settlement of Differences

The differing viewpoints and interpretations of this MoU shall be settled amicably by mutual consultation or negotiation.

Article V: Amendments, Duration and Termination

- 1) Amendments to this MoU can only be made by mutual consent for the two parties.
- 2) This MoU shall be in effect from the date of its signature and be valid for the duration of three (3) years from that date and will be automatically renewed on an annual basis thereafter unless terminated or replaced with a new MoU.
- 3) This MoU may be terminated by either party by written notice at least three (3) months prior to the termination date. Such notice of termination will not interfere with cooperative programmes currently underway. Such programmes will be allowed to continue until their conclusion.

Article VI: Notice
